## ORDER

## **WHEREAS:**

- A. By Letter L-28-15 dated July 9, 2015, the British Columbia Utilities Commission (Commission) accepted FortisBC Energy Inc.'s (FEI) 2015/16 Annual Gas Contracting Plan (ACP) as being in the public interest;
- B. On July 24, 2015, FEI filed with the Commission for acceptance under section 71 of the *Utilities Commission Act* (UCA) a Six-Year Baseload Gas Purchase Agreement with TD Energy Trading Inc. (Agreement);
- C. FEI requests that the details of the filing be kept confidential for reasons of commercial sensitivity;
- D. On August 6, 2015, FEI filed its response to the Commission's confidential information request dated July 31, 2015;
- E. By Order G-130-06 dated October 27, 2006, the Commission approved the Rules for Natural Gas Energy Supply Contracts (Rules). The Rules are intended to facilitate the Commission's review of natural gas energy supply contracts pursuant to section 71 of the UCA; and
- F. The Commission reviewed the filing and information request responses and is satisfied that the Agreement is consistent with the ACP, is in the public interest and that the information in the filing and associated documents should be kept confidential.
