O R D E R

WHEREAS:

- A. On May 6, 2015, FortisBC Energy Inc. (FEI) and The Corporation of the City of Victoria (City of Victoria) entered into a Fueling Services Agreement (City of Victoria Agreement) which establishes terms and rates for FEI's provision of the Compressed Natural Gas (CNG) fueling service from the CNG Station located at the FEI's Victoria Regional Office facility in Langford (Langford CNG Station);
- B. On June 10, 2015, FEI applied to the British Columbia Utilities Commission (Commission), pursuant to sections 59 to 61 of the *Utilities Commission Act*, for interim and permanent approval of the rates established in the City of Victoria Agreement, effective June 1, 2015 (Application);
- C. The Commission reviewed and considered the Application and determines that the City of Victoria Agreement and the rates established therein for CNG supply from the Langford CNG Station should be approved.

NOW THEREFORE pursuant to sections 59 to 61 of the *Utilities Commission Act*, the Commission orders as follows:

- 1. The rates established in the Fueling Services Agreement entered into by FortisBC Energy Inc. (FEI) and The Corporation of the City of Victoria (City of Victoria) (City of Victoria Agreement), which includes the Total Dispensing Rate that will apply to City of Victoria for Compressed Natural Gas (CNG) fueling service from the Langford CNG Station, are approved on permanent basis, effective June 1, 2015.
