Re: Pembina Kinder Morgan Canada (Jet Fuel) Inc. (PKMJF) – 2019 Tariff Filing Application – Project No. 1598984 – BCUC Request for PKMJF's response to Vancouver Airport Fuel Facilities Corporation (VAFFC) and Parkland Refining (B.C.) Ltd. (Parkland) request for further and better Information Request responses and adjournment of the regulatory timetable

Dear Ms. Twyman:

On June 16, 2020, pursuant to Order P-3-20, PKMJF filed responses to British Columbia Utilities Commission (BCUC) information request (IR) No. 3 and VAFFC and Parkland IR No. 2. On June 18, 2020, PKMJF filed with the BCUC confidential documents in response to certain VAFFC and Parkland IRs and requested the BCUC hold confidential these documents (Confidentiality Request), pursuant to Rule 18 of the BCUC's Rules of Practice and Procedure (Rules).

On June 18, 2020 VAFFC filed an application¹ with the BCUC seeking further and better responses to certain IRs attached as appendices (IR Application), pursuant to Rule 14.05 of the BCUC's Rules of Practice and Procedure (Rules), and requested the BCUC suspend the regulatory timetable until the BCUC makes any determination and PKMJF responds to any BCUC order. This position was also supported by Parkland in its submission dated June 19, 2020². In their submissions, both VAFFC and Parkland also filed requests to access all documents filed confidentially, should the BCUC accept PKMJF's Confidentiality Request.

The BCUC therefore requests PKMJF to provide a written response to the submissions made by VAFFC and Parkland by Tuesday, June 30, 2020. Further, the regulatory timetable as established by Order P-3-20 is adjourned, pending the outcome of the IR Application and any decision on PKMJF's Confidentiality Request will be addressed after the BCUC rules on the IR Application.
