ORDER

WHEREAS:

- A. On September 21, 2021, Toby Creek Utilities Co. Ltd. (TCU) filed an application with the British Columbia Utilities Commission (BCUC) for approval of its proposed rates and terms of service, pursuant to sections 58 to 61 of the *Utilities Commission Act* (Application);
- B. In the Application, TCU requests the following:
 - 1. Approval for proposed rates and terms of service as described in the Application and set out in TCU's proposed Electric Tariff; and
 - 2. Directions with regard to future proceedings, filings or reports required by the BCUC; and
- C. The BCUC has commenced review of the Application and determines that establishing a preliminary regulatory timetable is warranted.

NOW THEREFORE the BCUC orders as follows:

- 1. A public hearing for the review of the Application is established, as set out in the Regulatory Timetable attached as Appendix A to this order.
- 2. TCU is directed to provide this order and the Public Notice attached as Appendix B to this order to all of its customers, either by mail or e-mail, by Thursday December 16, 2021.
- 3. TCU is directed to publish the Public Notice attached as Appendix B to this order, in display-ad format in public locations within its service to provide adequate notice to the public by Thursday December 16, 2021.

4. TCU is to provide the BCUC confirmation upon completion of its actions in Directive #2 and #3 above by Friday, December 17, 2021.
5. In accordance with BCUC's Rules of Practice and Procedure, parties who wish to actively participate in this proceeding must submit the Request to Intervene Form, available on the BCUC's website at <https://www.bcuc.com/GetInvolved/GetInvolvedProceeding>, by the date established in the Regulatory Timetable.
