Permanent Rates and Agreement for Martin-Brower of Canada Co. for Fuelling Service from the Langford CNG Station

ORDER

WHEREAS:

- A. On May 26, 2023, FortisBC Energy Inc. (FEI) applied to the British Columbia Utilities Commission (BCUC), pursuant to sections 59 to 61 of the *Utilities Commission Act*, for approval of the rates established in a fuelling services agreement between FEI and Martin-Brower of Canada Co. (Martin-Brower) (Martin Brower-Langford Agreement), on permanent basis, effective June 12, 2023 (Application);
- B. By Order G-187-13 dated November 19, 2013, the BCUC found that FEI's compressed natural gas (CNG) fuelling station located at its Victoria Regional Office Facility in Langford, BC (Langford Fuelling Station) met the requirements for a prescribed undertaking as defined by the Greenhouse Gas Reduction (Clean Energy) Regulation;
- C. By Order G-311-21 dated October 29, 2021, the BCUC approved the rates established in a fuelling services agreement between FEI and ColdStar Solutions Inc. (ColdStar) (ColdStar Agreement) and between FEI and GFL Environmental Inc. (GFL) (GFL Agreement) on permanent basis, effective January 1, 2021, for ColdStar and GFL, respectively, to receive fuelling service from the Langford Fuelling Station (Langford Renewal Application); and
- D. On May 11, 2023, FEI and Martin-Brower entered into the Martin Brower-Langford Agreement which established the terms and conditions for Martin-Brower to receive CNG fuelling service from the Langford Fuelling Station, effective June 12, 2023;
- E. The BCUC has reviewed the Application and determines that approval of the proposed rates on a permanent basis is warranted.

Final Order 1 of 2

NOW THEREFORE pursuant to sections 59 to 61 of the *Utilities Commission Act*, the BCUC orders as follows:

- 1. The rates established in the Martin Brower-Langford Agreement are approved, on a permanent basis, effective June 12, 2023.
- 2. FEI is to file the Martin Brower-Langford Agreement in tariff supplement form for endorsement by the BCUC within 15 days of the date of this order.
