#### **ORDER**

#### **WHEREAS:**

- A. On December 21, 2021, British Columbia Hydro and Power Authority (BC Hydro) filed its 2021 Integrated Resource Plan (IRP) Application with the British Columbia Utilities Commission (BCUC), pursuant to section 44.1 of the *Utilities Commission Act* (UCA) and in accordance with Order G-28-21 dated January 27, 2021;
- B. By Order G-129-23 dated May 17, 2023, the BCUC established an amended regulatory timetable; and
- C. The BCUC determines that establishing an amended regulatory timetable is warranted.

#### **NOW THEREFORE** the BCUC orders as follows:

- 1. An amended regulatory timetable is established as set out in Appendix A to this order.
- 2. BC Hydro must provide a copy of this order and cover letter, within five business days of its issuance, electronically where possible, to all parties notified by BC Hydro in accordance with Order G-15-22.
