ORDER

WHEREAS:

- A. On July 4, 2024, British Columbia Hydro and Power Authority (BC Hydro), pursuant to sections 58 to 61 of the *Utilities Commission Act* (UCA), filed with the British Columbia Utilities Commission (BCUC) an application (Application) for amendments to Tariff Supplement No. 79 and Attachment C of the Open Access Transmission Tariff (OATT), including:
1. Administrative amendments to Attachments 1 and 2 to Tariff Supplement No. 79 to incorporate the Site C generating plant in advance of its commercial operation date;
 2. Additional amendments to Tariff Supplement No. 79 of an administrative or housekeeping nature; and
 3. Housekeeping amendments to Attachment C of the OATT to remove references to Mandatory Reliability Standard MOD-029-2a, which has been retired effective February 1, 2024, as well as amendments to remove URL links from Attachment C.
- B. The BCUC has commenced review of the Application and determines that establishment of a written comment process is warranted.

NOW THEREFORE the BCUC orders as follows:

1. A regulatory timetable for review of the Application is established as set out in Appendix A to this order.
2. BC Hydro is directed to make the Application available on its website and provide notice of the Application to BC Hydro OATT customers by Wednesday, August 7, 2024.
3. BC Hydro is directed to provide written confirmation of compliance with Directive 2 of this Order by Monday, August 12, 2024.

4. Parties wishing to provide comments on the Application are invited to submit a letter of comment by Wednesday, August 21, 2024. Letters of comment must be in the Letter of Comment Form available on the BCUC's website at: <https://www.bcuc.com/Forms/LetterOfComment> and submitted by email to commission.secretary@bcuc.com or by mail to the British Columbia Utilities Commission, Suite 410, 900 Howe Street, Vancouver, BC, V6Z 2N3. Comments are to be limited in scope to the amendments to Tariff Supplement No. 79 and Attachment C of the OATT proposed by BC Hydro in the Application.
